2025-26 Memorandum of Coverage – Liability Program President Finlay presented the 2025-26 Memorandum of Coverage – Liability Program item.

Paul Zeglovitch, Claims and Insurance Director, reported that staff discussed revisions with the Authority's General Counsel, Byrne Conley and have agreed to the following changes:

• Pages 6-16: Definitions

Added definitions for the terms Annual Aggregate Deductible, Earth Movement, Endorsement, Member Retained Limit, Protection Limit and Sublimit. Some of these terms had been previously used, but did not necessitate definition, while others are new to the document and are significant enough that they required definition.

• Page 20: Exclusion "P"

We have amended this exclusion to clarify that the approval or disapproval of land use regulations is both discretionary and nondiscretionary. We have also clarified that the approval or disapproval of ordinances includes any licensing issues and also includes massage parlors.

• Endorsement #2

After considerable consultation with the Managers Committee and the Executive Committee, we have adopted a Sublimit on coverage for Earth Movement related claims. This necessitated creating a new endorsement to the Primary Liability portion of the MOC. The Endorsement sets forth limits of \$10M, per member, per coverage period and a pool wide limit of \$30M per coverage period, to be shared by all members, if necessary. These limits are regardless of the number of claims filed. Endorsement #2 was previously utilized to list the Excess Liability Program members and their corresponding Member Retained Limits. We have moved that information to the newly formed Endorsement #3.

Endorsement #3 was amended to reflect that Pacific Grove and San Luis Obispo have increased their Member Retained Limits from \$150,000 to \$200,000 and \$500,000 to \$1,000,000, respectively.

Alex Smith, Chief Executive Officer, stated that the Coverage Committee met prior to the Executive Committee and approved of the recommendation.

Director Santa Ines moved to approve the changes to the 2025-26 Memorandum of Coverage – Liability Program as recommended by the Coverage Committee. The motion was seconded by Director Chavez. The motion carried unanimously by roll call vote.

	Jeff Rush, Workers' Compensation Program Manager, stated that the only substantive change proposed was to extend coverage for interns who are utilized by members. Volunteers are already covered under the existing memorandum.
	Alex Smith, Chief Executive Officer, stated that the Coverage Committee met prior to the Executive Committee and approved of the recommendation.
	Director Croft moved to approve the changes to the 2025-26 Memorandum of Coverage – Workers' Compensation Program as recommended by the Coverage Committee. The motion was seconded by Director Santa Ines. The motion carried unanimously by roll call vote.
APPROVAL 2025-26 Memorandum of Coverage – Property Program	President Finlay presented the 2025-26 Memorandum of Coverage – Property Program item.
	 Chris Gray, Insurance Programs Manager, reported the following coverage enhancements for the property program: Increase of Earthquake/Flood coverage from \$200M to \$225M
	 Increase of All Risk coverage from \$500M to \$750M Increase of Terrorism coverage from \$100M to \$150M
	Gray stated that the changes coincided with an increased member deductible from \$10,000 to \$15,000, which resulted in a premium credit for the Authority's property program.
	Alex Smith, Chief Executive Officer, stated that the Coverage Committee met prior to the Executive Committee and approved of the recommendation.

Director Chavez moved to approve the changes to the 2025-26 Memorandum of Coverage – Property Program as recommended by the Coverage Committee. The motion was seconded by Director Waronek. The motion carried unanimously by roll call vote.

Attached is the Treasurer's Monthly Compliance Report for June 2025

Directly held investments, as of June 30, 2025, totaled \$338.9 million. Cash held in LAIF was \$23,364 and the money market account balance was \$54,949. Cash held in the Los Angeles County Pooled Investment Fund was \$111,351. Cash held in CAMP was \$4.5 million. Altogether, cash and investments totaled \$343.6 million at the end of the month.

The annualized yield to maturity at cost earned by direct investments was 3.51%. Accrual basis earnings were \$862,975. The quarter-to-date yield reported by LAIF was 4.27%, and the money market account yield was 4.22%. The Los Angeles County Pooled Investment Fund yielded 3.60% and CAMP yielded 4.40%.

Subject: Publicly Available Salary and Pay Schedule

The Authority contracts with the California Public Employees' Retirement System (CalPERS) to provide retirement benefits for its employees. California Code of Regulations, Title 2, Section 570.5 requires governing bodies of local agencies contracting with CalPERS to approve and adopt a publicly available pay schedule in accordance with public meeting laws. Additionally, Title 2, Section 570.5 requires the following:

- 1) Identifies the position title for every employee position;
- 2) Shows the pay rate for each identified position, which may be stated as a single amount or as multiple amounts within a range;
- 3) Indicates the time base, including, but not limited to, whether the time base is hourly, daily, bi-weekly, monthly, bi-monthly, or annually;
- 4) Is posted at the office of the employer or immediately accessible and available for public review from the employer during normal business hours or posted on the employer's internet website;
- 5) Indicates an effective date and date of any revisions;
- 6) Is retained by the employer and available for public inspection for not less than five years; and
- 7) Does not reference another document in lieu of disclosing the pay rate.

These CalPERS requirements are intended to enhance the disclosure and transparency of public compensation by requiring that the pay rates be listed on a single pay schedule or a single document.

The Authority's Salary and Pay Schedule contained in Exhibit "A" reflects the following changes (a) salary range change for the Facilities Specialist classification effective April 28, 2025, (b) salary range change for the Insurance Program Manager classification, effective July 1, 2025, (c) the agreed upon cost-of-living increase for all classifications as determined by the meet and confer process effective July 1, 2025, (d) a reclassification of one of the Administrative Assistant positions to Administrative Analyst, and (e) a reclassification of one of the Administrative Administrative Analyst positions to Management Analyst.
